The Budget Committee's Special Meeting was called to order at 11:15 a.m. by the Chairperson.

I. Approval of the Minutes

Chairperson Stevenson Kotton

- A. The minutes of April 20, 2021 were reviewed by the committee.
 - 1. There being no corrections, a motion was made by the Developmental Education Department's Chairperson to approve the minutes. The motion was seconded by the Dean of WAVES, and the motion was successfully carried by the majority.

II. New Matters Arising

A. FY 2019 Audited Carryover Funds

- 1. The Chairperson/VPBAA briefly explained to the committee members of the available carryover funds amounting \$360,000 (three hundred sixty thousand dollars)
 - a) \$150,000 (One Hundred Fifty Thousand Dollars) will be towards the Strategic and Programmatic Priority Initiatives for FY 2022.

- b) \$210,000 (Two Hundred and Ten Thousand Dollars) will be towards the President's Initiatives for FY 2022.
- c) The Chairperson of the Marshallese Studies Department raised a concern on the availability of an "emergency fund" should another pandemic occur in the coming future.
 - (1) The Chairperson/VPBAA reassured the committee members that an allocation of \$50,000 (fifty thousand dollars), in which it's allocated every fiscal year from the unused funds.

III. **Matters from Previous Meeting**

A. FY2022 Budget Projections

- 1. The Chairperson/VPBAA informed the committee members of CMI's Budget Breakdown for FY 2022.
 - a) The estimated budget breakdown for FY 2022 is approximately \$11MM.
 - b) The Chairperson/VPBAA shared with the committee members that the Microix Training, conducted by the Business Office, is scheduled for Monday, May 3, 2021 and Tuesday, May 4, 2021, at 11:00 am.
 - (1) The Chairperson/VPBAA explained to the committee members the budget proposal process.
 - (2) The VPBAA recommended attendees to bring in their laptops to start working on balancing their proposed budget.
 - c) On Thursday, May 6, 2021, the Budget Module will be sent out to each department, via email, and will be available for 2 weeks.
 - (1) The Chairperson/VPBAA stated the importance of the narrative items to be explained thoroughly when they're submitted for consideration.
 - (2) The Chairperson for the Marshallese Studies Department raised a concern of the budget proposal deadline, conflicting with the grading schedules for the faculties.
 - (a) Hence, VPBAA extended the deadline to Thursday, May 21, 2021.

B. FY 2022 Budget Ceiling

- 1. The VPBAA shared with the committee members of not receiving any updates from the RMI Ministry of Finance in regards to the budget ceiling for FY 2022.
 - As a result, the VPBAA informed the committee members that the budget ceiling for FY 2022, will be the same as it was for FY 2021.


C. DE Center's Budget Proposals
