2. Consider for approval
  - ICS 100 Computer Literacy, new course, 2 credits  
Since 100 level course designations have indicated in the past a developmental level course, the course will be designated ICS 106. It is designed to replace ICS 103, Keyboarding, and BIT 102, Discovering the Internet, and will be open to developmental level students. Students may test out of it. It will not be listed as a prerequisite to ICS 101. Outline needs PLO linkages.  
Discussion with concerns voiced that the competency areas listed for the course description do not match the SLO's on the course outline. Since the proposed course competencies are the course outcomes, then the proposed course outline needs to match the course proposal provided by BIT Department to the CAC.  
Course Outline tabled.
3. SPED 160, Introduction to Special Education I, new course, 3 credits
  - MoE requested that CMI provide a course in special education. Education Department will pilot summer 2009 a Special Education Workshop and then run this course in the fall semester.

4. CHN 213, Chinese III, new course, 3 credits
