The meeting was called to order at 11:05 A.M. in WH202 by Mary Van Auken, Chair.

Background:

a. On August 5, 2016, CAC accepted the "CAC Assessment Reflection, and Recommended Remedial Actions 2015-2016" which included the section

IV. Remedial Actions

Due to the amount of work that the CAC is required to do, the committee would be more efficient if it was divided into two committees with different membership (some people may be on both committees). The committees should be the Curriculum Committee and a separate Assessment Committee should be formed.

b. On August 5, 2016, CAC approved a Curriculum Committee RSA in anticipation of establishing separate committees.

- c. On August 16, 2016, both documents, along with an Assessment Committee Proposal were presented to the Executive Council (EC). During that meeting, motions to approve each of the documents were passed.
- d. On August 26, 2016, in Faculty Senate, a motion that CAC meet under its last approved RSA was approved.
- e. On August 31, 2016, EC reconsidered its prior vote on adopting CAC recommendations and requested further discussion on this issue.

Actions

- f. A motion was made, seconded, and passed that the CAC Chair speak with Faculty Senate on September 9. She will present rational for why CAC reported their actions to Faculty Senate, but requested approval from EC. The rationale will include the BOR Policy and Procedures 620.01 which provides that the Curriculum Committee be a standing committee of the college and 620.04 #5 which states that, "Any change in the Curriculum Committee polices (sic) (except changes as defined in CMI Policy 141.00) shall be forwarded to the Executive Council for review and approval. If approved by the Executive Council, the changes shall be forwarded to the Board of Regents for final approval." She will also present the RSA for the Curriculum Committee and the Assessment Committee Proposal and ask for feedback from the Faculty Senate.
- g. A motion was made, seconded, and passed that the Curriculum Committee review and draft revisions to relevant sections Board of Regents Policy and Procedures (adopted December 15, 2003). Those sections consist primarily of 620.04 and 620.05. If and when approved, the Committee will follow established procedures for reporting and submitting these recommendations.
