- Math Placement test portion was given to Dr. Nish for review.
- > The CAP Test is now being referred to as the Computer Literacy Placement Test.
- ➤ The EMC recommendation from March 24th, 2017, meeting has been sent to EC for approval for their Special meeting on March 29, 2017.
 - **Recommendation:** All required tests for incoming CMI students are not required for admissions but are required for placement.
