The Enrollment Management Committee's first meeting for the month of May 2021 was called to order by the Chairperson/VPASA at approximately 11:16 a.m.

After the recitation of CMI's Mission, the committee reviewed the previous meeting minutes from April 15, 2021. After the minutes were reviewed and revised, a motion was made by the Director of Financial Aid, seconded by the Acting Dean of AA. The motion was successfully carried by the majority with 2 abstentions.

I. Review/Approval of the Previous Minutes

A. After the recitation of CMI's Mission, the committee reviewed the previous meeting minutes from April 15, 2021. After the minutes were reviewed, a motion was made to approve the minutes by the Director of Financial Aid. The motion was seconded by the Acting Dean of AA, and it was successfully carried by the majority with 2 abstentions.

II. Accreditation Update

- A. The committee reviewed and discussed Assessment II.C.2.:
 - 1. "The institution identifies and assesses learning support outcomes for its student population and provides appropriate student support services and programs to achieve those outcomes. The institution uses assessment data to continuously improve student support programs and services."
 - a) The committee discussed ways to improve the program reviews and the difference between "learning support" programs and "student support programs and services" and their outcomes.



(1) The Chairperson suggested that EMC, and all the student support services, should discuss the program reviews and the assessment outcomes and ways to make suggestions towards improvement.

III. Enrollment Management Wapepe - Dean of WAVES

A. The Dean of WAVES updated the committee on the expansion of the ABE program. It's now been expanded to Kili and Santo.

IV. Reports from the Subcommittees

- A. Admissions Board- VPASA
 - 1. Admission for the Summer Semester is over 200 students.
 - a) As a result, no late applications are being accepted.
- B. Calendar Catalog Acting Dean of AA
 - 1. The subcommittee will meet on Monday, May 10, 2021.
- C. Placement Director of Admissions
 - 1. As a result of their last meeting, the subcommittee has decided to give the revised test to students attending the summer semester.
 - 2. The Director also brought up the difficulty for student's to obtain their transcripts
- D. Internships, Apprenticeships, and Career Opportunities Task Force Director of WAVES
 - 1. The document has already been sent to the Faculty Senate, however, no feedback has been received.
 - 2. The Dean of WAVES will resent the document and share via google.doc with the Faculty Senate.

V. Recognition of Prior Learning

- A. Draft Procedures
 - 1. After a final review, the Faculty Senate moved to approve the draft Recognition of Prior Learning Procedures, seconded by the Director of Admission. The motion was passed unanimously with one abstention.

DECISION

The Recognition of Prior Learning Procedures was approved, as presented.

B. Application for Recognition of Prior Learning Form

1. Having no modifications, the Director of Admission made a motion to approve the Application for Recognition of Prior Learning Form, seconded by the Acting Dean of Academic Affairs. The motion was successfully carried by the majority with one abstention.

DECISION

The Application for Recognition of Prior Learning Form was approved with no modifications.



C. Recognition of Prior Learning Decision Appeal

1. Having no corrections, the Acting Dean of Academic Affairs made a motion to approve the Recognition of Prior Learning Decision Appeal. The motion was seconded by the Director of Admissions, and was successfully passed by the majority with one abstention.

DECISION

The Recognition of Prior Learning Decision Appeal was approved, as presented.

D. Recognition of Prior Learning by External Certification

1. With no modifications, comments, or questions, the Acting Dean of Academic Affairs moved to approve the Recognition of Prior Learning by External Certification. The Director of Admission seconded the motion. The motion was passed by the majority with one abstention.

VI. Survey of Entering Student Engagement

- A. The EMC precisely reviewed the SENSE 2020 executive summary.
- B. Suggestions were made by the members after identifying 2 of the results that needed urgent improvements.
 - 1. It was suggested by the members that advisors/students relationships needed to be strengthened.
 - 2. A student's advisor's role needs to be emphasized during the registration process.
- C. The Action: Acting Dean of Academic Affairs will share the SENSE 2020 results with the Faculty Senate and discuss possible solutions in addressing the results.

ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, College of the Marshall Islands (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign system. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to this Electronic Record and Signature Disclosure (ERSD), please confirm your agreement by selecting the check-box next to 'I agree to use electronic records and signatures' before clicking 'CONTINUE' within the DocuSign system.

Getting paper copies

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. You will have the ability to download and print documents we send to you through the DocuSign system during and immediately after the signing session and, if you elect to create a DocuSign account, you may access the documents for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

Withdrawing your consent

If you decide to receive notices and disclosures from us electronically, you may at any time change your mind and tell us that thereafter you want to receive required notices and disclosures only in paper format. How you must inform us of your decision to receive future notices and disclosure in paper format and withdraw your consent to receive notices and disclosures electronically is described below.

Consequences of changing your mind

If you elect to receive required notices and disclosures only in paper format, it will slow the speed at which we can complete certain steps in transactions with you and delivering services to you because we will need first to send the required notices or disclosures to you in paper format, and then wait until we receive back from you your acknowledgment of your receipt of such paper notices or disclosures. Further, you will no longer be able to use the DocuSign system to receive required notices and consents electronically from us or to sign electronically documents from us.

All notices and disclosures will be sent to you electronically

Unless you tell us otherwise in accordance with the procedures described herein, we will provide electronically to you through the DocuSign system all required notices, disclosures, authorizations, acknowledgements, and other documents that are required to be provided or made available to you during the course of our relationship with you. To reduce the chance of you inadvertently not receiving any notice or disclosure, we prefer to provide all of the required notices and disclosures to you by the same method and to the same address that you have given us. Thus, you can receive all the disclosures and notices electronically or in paper format through the paper mail delivery system. If you do not agree with this process, please let us know as described below. Please also see the paragraph immediately above that describes the consequences of your electing not to receive delivery of the notices and disclosures electronically from us.

If you created a DocuSign account, you may update it with your new email address through your account preferences.

To request paper copies from College of the Marshall Islands

To request delivery from us of paper copies of the notices and disclosures previously provided by us to you electronically, you must send us an email to ksebastian@cmi.edu and in the body of such request you must state your email address, full name, mailing address, and telephone number. We will bill you for any fees at that time, if any.

To withdraw your consent with College of the Marshall Islands

To inform us that you no longer wish to receive future notices and disclosures in electronic format you may:

i. decline to sign a document from within your signing session, and on the subsequent page, select the check-box indicating you wish to withdraw your consent, or you may;

ii. send us an email to ksebastian@cmi.edu and in the body of such request you must state your email, full name, mailing address, and telephone number. We do not need any other information from you to withdraw consent. The consequences of your withdrawing consent for online documents will be that transactions may take a longer time to process.

Required hardware and software
