As a follow up to the previous message, we also want to look at using (1) 1 ½" conduit for the HDMI cable, CAT 6, and Coax Cables as one drop instead of multiple ¾" conduits. We also want to move away from using a standard outlet and start using single-ganged outlets specifically designed to handle this condition – similar to the attached. The unit shown in the attachment is for reference only. If others are available that are more cost effective but are configured the same, then they can be used.

Moving forward, please make sure we have a built-in TV/Data/Cable outlet next to the outlet for every TV monitor.

- Prototype Architects Make sure this is identified on the appropriate drawings and send the updates documents to me.
- Site-Adapt Architects Make sure the CDs for all active project include this.
- GC's Make sure this is accounted for whether it is shown on your documents or not.

Using the proposed ganged outlet should work better than side-by-side outlets but still needs to be placed in a discreet location to help hide all wires. If you have any questions regarding this, please contact me. Thanks.
