CLARIFICATIONS AND COMMENTS:

The following field changes shall be implemented:

- 1. Rework the grading along the perimeter of the site (South and West) so that the top of the depressions are at elevation 663. Realign the yard drains so they fit in the low spot of the referenced depressed areas, match existing TCs, inverts, and pipe lengths and slopes as indicated in the plans. Plans provide updated calculation values for MDOT routings. Any questions regarding these changes should be discussed with Taco Bell's Construction Manager.
- 2. Install the larger powersoak sink.
- 3. Square D panel to be installed instead of the CPI panel.
