GRADING & DRAINAGE

The plans associated with this permit were reviewed under Electronic Plan Review (EPR). The applicant is required to provide a full size 24" x 36" copy of the approved plans to the civil inspector prior to the start of construction.

Asphalt Pavement Restoration Requirements

Phoenix City Code (PCC) Chapter 31, Section 31-49.1 (Ordinance G-6395)

IF THE CUT(S) IS INTO ASPHALT THAT IS LESS THAN 24 MONTHS OLD

Any person cutting into or disturbing pavement that is LESS THAN 24 MONTHS OLD is required to restore the asphalt using Mill and Overlay process? At a minimum depth of one and one-half (1?) inches? To the full width of all impacted lanes of an arterial (Major) or Collector street and to the full width of a Local street. The Mill and Overlay treatment must extend a minimum of 25 feet in both directions of the pavement cut. In order to comply with PCC Section 31-49.2 (liability of person repairing street for defective repair), the asphalt materials shall be a City of Phoenix mix design for a Mill and Overlay.

IF THE CUT(S) IS INTO ASPHALT THAT IS OLDER THAN 24 MONTHS

a minimum of 25 feet in both directions of the pavement cut(s).

Any person cutting into or disturbing pavement on an arterial (Major), Collector, or a Local street that is OLDER THAN 24 MONTHS is required to Crack-Seal the outside edge of the restored area of the street cut or disturbance. In addition to the application of a Crack-Seal, the permittee shall:

*For a pavement cut into an arterial (Major) or a Collector street, the permittee shall apply A Type IV (Micro-seal) Slurry to the half-width of the Arterial or Collector street; The Type IV Slurry must extend a minimum of 25 feet in both directions of the pavement cut(s). *For a pavement cut into a Local street, the permittee shall apply A Type II Slurry Seal to the full width of the Local street that must extend
